### **Topics Covered:**

The meeting was called to order and 2:57 pm and all were welcomed by the acting Chair, Ms. Lourdes Diaz, Principal.

Quorum was established.

The minutes of the September meeting were reviewed. Mr. DePriest raised a question regarding the reference to "maximizing acceleration" in the seventh paragraph. Ms. Diaz explained that "acceleration" refers to AP exams, Dual Enrollment classes, etc. She also explained that last year the school was below 50% and were looking to "maximize" or increase the percentage this year. Mr. Green made a motion to amend the minutes to clarify usage of "maximize." Mr. Moffi seconded the motion. There was 1 nay from Mr. DePriest.

Ms. Diaz raised the EESAC Composition Waiver. This waiver would decrease the number of EESAC members from 33 down to 23 members, allowing for Quorum to be more easily established with only 12 voting members. The group deliberated on the appropriate number of members and ultimately settled on the following EESAC Composition:

- 1 Principal
- 1 Adult Vocational Principal
- 4 High School Teachers
- 1 UTD Steward
- (2 Adult Teachers

- 4 Parents
- 4 High School Students
- 2 Educational Support Employees
- 1 Adult Student
- 3 Business and Community Members

Mr. Green made a motion to amend the EESAC Composition Waiver. Mr. Zilka seconded the motion. There was 1 nay from Mr. DePriest.

Ms. Sears spoke about the School Improvement Plan (SIP). Each school is required to set 1 goal. For MLEC, the goal is to continue and expand rigor through usage of data. Utilizing data and assessments will help to encourage and support students' needs. As an example, the Algebra II Topic Assessment data would show the teacher which students are struggling with equations with more than 1 variable. The teacher reviews this information with those students and points them toward what they can do to improve. The group discussed the use of this data for other courses; however, for now teachers can only access their own areas. It was noted that new assessments would need to be pulled manually by Ms. Viada.

Ms. Viada reviewed the Testing Results. She stated that all 10th graders and most of the 11th graders would be taking the PSAT next Wednesday (October 19). This would be free for the 10th graders. They had a trial run the previous week and would get those results in December.

Ms. Viada stated that there would be English Language Arts (ELA) and Algebra retake exams. Approximately 137 students from the 11th and 12th grade still need to pass the ELA to graduate. Administrators would continue assessments and re-evaluate at mid-year point (January). Ms. Viada noted that students need to pass both Algebra I and ELA to graduate.

A Parent asked why MLEC had been down-graded to a B school. Ms. Diaz explained the reason was two-fold. First, the State took away "banking," which would allow students to transfer their middle school scores. This impacts MLEC more so than other schools, because a large amount of students who take Algebra and Geometry used to count 3 times, but now only count once under the new rules, resulting in a seemingly lower score. Ms. Diaz did note that in English, they are in the 70th percentile. Secondly, the State took away weighting. Whereas before students could count as 1.6 if they took a lot of AP courses, they now count as 1. MLEC is working with Miami Dade College (MDC) to increase the number of Dual Enrollment students through the Student Life Skills (SLS) course, which only requires a 2.5 GPA.

Ms. Diaz announced that next week MLEC was having Academy Nights to inform parents about the different Academies and provide information required to graduate. She also announced their College Fair would be next Monday, October 17th.

The next EESAC meeting is scheduled for November 3.

Mr. Green motioned to adjourn the meeting. Ms. Viada seconded the motion. The meeting adjourned at 3:36pm.
